Wedding Policies

- ⌘ Non refundable deposit required to reserve facility for your reception.
- ⌘ Deposit return consideration if Frem C.C has the opportunity to rebook reception of same size and revenue.
 - ⌘ A minimum of 125 guaranteed count is required to book a Saturday wedding reception.
- ⌘ No alcohol may be brought onto Frem C.C property. Food shall be presented and prepared by Frem C.C.
 - ⌘ Frem C.C will abide to all Pa Liquor Control Board Regulations.
 - ⌘ Guests must have proper identification in order to be served any alcoholic beverages.
 - ⌘ We reserve the right to stop individual service of alcohol if visibly intoxicated.
 - ⌘ No shots or pitchers of beer dispensed.
 - ⌘ Menu and linen selection must be confirmed 60 days prior to the reception.
 - Due to any unforeseen circumstances, pricing is not guaranteed until this time.
 - ⌘ Exact guest count and menu choices are required 10 days prior to the reception
 - ⌘ Your final meeting with the Banquet Coordinator must be held 72 hours prior to the reception and final payment due.
 - ⌘ Pertinent items to the wedding should be delivered 72 hours prior to the Reception.
 - ⌘ Place cards should be in alphabetical order.
 - ⌘ Frem C.C. does not assume any responsibility for damage or loss of any merchandise or articles prior to, during or after the reception.
 - ⌘ The person signing the contract will be held responsible for any damage to the property caused by guests.
 - ⌘ No tape, nails, or staples may be use on ceilings & walls.
 - ⌘ The use of glitter, confetti, or sparkles loosely place on tables is not allowed.
 - Any use of this material will constitute a \$100.00 additional clean up fee.
 - ⌘ All extension cords must be securely taped to floor.
 - ⌘ Flammable products not permitted
 - ⌘ Smoking is not permitted in the ballroom area.
 - ⌘ Props, centerpieces created by decorators or florist must be removed at the conclusion of the reception.
 - ⌘ No reception is to extend beyond the contracted times unless previous approval granted. Additional fees may apply.
 - ⌘ In the event of a strike, accident, illegality or act of God it becomes impossible for Frem C.C to perform under this contract, because of power, fire, water or other related problems or damage. Frem C.C shall be excused from performance.
 - Frem C.C. will be liable only for repayment of deposit.
